Terms and Conditions**

### Background to Promotion

1. Mirvac (WA) Pty Limited (**Mirvac** or the **Promoter**) recently introduced the ‘Refer a Friend’ promotion (**Promotion**).
2. The Promotion will run for a limited time. The Promotion commences at 10am WST on 12 August 2019 and ends at 5pm WST on 30 June 2021 (**Promotion Period**).
3. Under the Promotion, subject to these terms and conditions, Mirvac will provide a Pre-paid EFTPOS Gift Card to the value of \$2,000 (**Referral Sum**) to a Referring Party and the Eligible Purchaser if an Eligible Purchaser purchases land at Mirvac’s developments at Madox, Iluma Private Estate, Osprey Waters, One71 Baldivis and/or Henley Brook Private Estate (**Eligible Property**) during the Promotion Period.
4. The following terms and conditions apply to the Promotion. By participating in the Promotion, Eligible Buyers and Referring Parties agree to be bound by these terms and conditions.

### Promotion Terms and Conditions

The Referring Party and Eligible Buyer will be eligible for the Promotion if the following terms and conditions are satisfied:

5. A **Referring Party** is a person who:
  - a. is a natural person over the age of 18 years and are not a company, registered builder, superannuation funds or persons acting as agent on behalf of other persons;
  - b. has entered into an unconditional contract and settles with Mirvac to purchase an Eligible Property; and
  - c. introduces an Eligible Buyer by completing in full and signing a “Refer a Friend’ Introduction Form” (**Introduction Form**) and providing it to one of Mirvac’s sales consultants.
6. An **Eligible Buyer** is:
  - a. a natural person over the age of 18 years and are not a company, registered builder, superannuation funds or persons acting as agent on behalf of other persons
  - b. not an employee, agent, consultant or related entity of Mirvac;
  - c. a person who has been referred to Mirvac or the Eligible Property by an eligible Referring Party and must not have been referred to Mirvac or the Eligible Property by a referring channel agent;
  - d. a person who, at the time of the referral for the Promotion, must not already be entered on the Mirvac database; and

- e. a new introduction to Mirvac and the Eligible Property and must not, in the reasonable opinion of Mirvac, exist in any current/present negotiations for the purchase of an Eligible Property.
7. The Promotion is only available where a Referring Party introduces an Eligible Buyer who:
  - a. exchanges an unconditional contract of sale with Mirvac for the acquisition of an Eligible Property (**Contract**) during the Promotion Period; and
  - b. settles the Contract on the due date for settlement under the Contract.
8. The Introduction Form must be received and acknowledged by Mirvac prior to the Eligible Buyer entering into the Contract, the form of acknowledgement being the provision by Mirvac to the Referring Party by hand, post, or email of a copy of the Introduction Form signed, dated, and time-stamped or time-endorsed by an authorised officer or agent of Mirvac.
9. The Referring Party must either:
  - a. provide their Australian Business Number (**ABN**) where indicated on the Introduction Form, if they have one; or
  - b. complete a Statement by Supplier form (**Attachment A**) and return it to Mirvac.
10. If these terms and conditions are satisfied, Mirvac will provide the Referral Sum to the Referring Party and the Eligible Buyer within a reasonable period after settlement of the Contract by the Eligible Buyer.
11. The Promoter shall notify the Referring Party if they qualify for a Gift Card. Any Referring Party who is not eligible or not entitled to qualify for a Gift Card under the terms and conditions of this Campaign, will not be notified.
12. The Referral Sum payable under this Promotion will not be deducted from the purchase price under the Referring Party / Eligible Buyer's Contract and is non-transferrable, non-refundable and cannot be exchanged for cash.
13. Mirvac reserves the right, at its absolute discretion, not to accept a referral.
14. If a referral is not accepted, Mirvac is not under any obligation to enter into any discussion with a Referring Party or to provide any details as to the reasons why a referral has been declined.
15. There is no limit to the number of Eligible Buyers that the Referring Party may refer under this Promotion.
16. Where an Eligible Buyer is referred by more than one Referring Party, only the first referral received and acknowledged by Mirvac, (as determined by Mirvac in its absolute discretion) will be entitled to qualify for the Promotion.
17. Mirvac shall notify the Referring Party in writing by email and by phone if they qualify for the Promotion within 14 days after the Eligible Buyer satisfies the requirements set out in these terms

and conditions. A Referring Party who is not eligible or not entitled to qualify for the Promotion under these terms and conditions will not be notified.

18. The Referral Sum may be subject to terms and conditions of the gift card issuer. Any dispute pertaining the gift card is strictly between the Referring Party and the provider.
19. These cards must be activated by the within 3 months of issue and must be redeemed within 12 months of activation or as otherwise provided by the terms and conditions of the card issuer.

### Further Terms and Conditions of Promotion

The following additional terms and conditions also apply to the Promotion:

20. The Eligible Buyer and Referring Party acknowledge and agree that the Promotion is non-transferrable, non-refundable and cannot be exchanged for cash. All taxes which may be payable as a consequence of receiving the Referral Sum or participating in the Promotion are the sole responsibility of the Eligible Buyer and Referring Party.
21. The Eligible Buyer and Referring Party must disclose the contents of this Promotion to any lending institution providing finance to the Buyer and Referring Party to assist with the purchase of the Property.
22. The Eligible Buyer and Referring Party forfeit all rights to receiving or participating in the Promotion if the Eligible Buyer and Referring Party do not comply with any of these terms and conditions or any term or condition under the Contract.

25. Mirvac reserves the right, at its sole discretion, to cancel, terminate, modify, extend or suspend the Promotion at any time without notice.
26. If there is any inconsistency between these terms and conditions and the provisions of the contract of sale entered into by a person participating in the Promotion, the contract of sale prevails.
27. These terms and conditions are governed by the laws of Western Australia.
